Liability/Medical/Waiver Release Form

A minor (hereinafter "Minor"), hereby grant the permission to allow minor to participate in the programs/classes to be conducted by KJC Enterprises, Inc. I, in my own behalf and/or on the behalf of the minor, further agree to release and hold harmless KJC Enterprises, Inc., the hosting site, on whose premises the games/clinic will occur, the affiliates of KJC Enterprises, Inc. and the location and respective directors, officers, representatives, members, agents, and employees of KJC Enterprises, Inc. from any and all liability for negligence or any other claim judgement, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the practice or competition, including any claim arising out of connected with any illness or injury (minimal, serious, catastrophic and/or death) that myself and/or minor may incur or sustain during the practice or competition. I further expressly agree to indemnify and hold harmless Releases and Releasees' heir, successors, assignors, executors and administrators against loss from any further claims, demands, or actions that may subsequently be brought by myself and/or, minor, or by any other persons on the account of damages of any character resulting to myself and/or minor in any way from the foregoing activities. I further agree to reimburse and make good to Releasees any loss or costs Releasees may have to pay as a result of any such action, claim, or demand.

The Agreement, and all transactions contemplated hereby, shall be governed by, construed and enforced in accordance with applicable state law. Any and all claims, controversies or disputes arising out of relating to this Agreement, or the beach thereof, which means unresolved after direct negotiations between the Parties, shall first be submitted to confidential mediation in accordance with the rules, procedures, and protocols for mediation of disputes of applicable state law then in effect. If any issues, claims, or disputes remain unresolved after mediation concludes, the Parties agree to submit any such issues to binding arbitration before one/three arbitrator(s) in accordance with the rules, procedures, and protocols for arbitration of disputes of applicable state law then in effect. The parties further agree that the award of the arbitrator(s) is binding upon the Parties, that all expenses of such mediation and arbitration shall be borne by the losing Party and that any judgement upon the award rendered may be entered into any court of competent jurisdiction.

I hereby consent without further consideration or compensation to the use (in full or in part) of all pictures and/or videos taken of myself and/or on the behalf of the minor. I also consent to use or release of voice recordings made of myself and/or on the behalf of the minor and/or written extraction, in whole or in part. Use may include but not limited to internet company website and marketing materials.

In the event that any part of this Agreement is construed as unenforceable, the remaining parts of the Agreement shall remain in full force and effect as though the unenforceable part and/or parts were not written into this Agreement.

I, in my own behalf and/or on the behalf of the minor, hereby warrant that I have read this Liability Release in its entirety and fully understand its contents. I, in my own behalf and/or on behalf of the minor, am aware that this Liability Release releases KJC Enterprises, Inc. from liability and contains an acknowledgement of my voluntary and knowing assumption of the risks of injury or illness. I, in my own behalf and/or on behalf of the minor, further acknowledge that nothing in this Liability Release constitutes a guarantee that the practice or competition will occur. I, in my own behalf and/or on behalf of the minor, have signed this document voluntarily and of my own free will.

Medical Release: I, in my own behalf and/or on behalf of the minor, acknowledge and agree that such participation subjects myself and/or minor to possibility of physical illness or injury (minimal, serious, catastrophic and/or death) and that I, in my own behalf and/or minor, acknowledge that I and/or the minor is assuming the risk of such illness or injury by participating in the clinic/practice/competition. In the event of such illness or injury, I authorize KJC Enterprises, Inc. to obtain necessary medical treatment of the minor and hereby, in my own behalf and/or on the behalf of the minor release and hold harmless Releasees in the exercises of this authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on my behalf and/or on the behalf of the minor for any illness or injury that I and/or the minor may sustain during the clinic/practice/competition and while traveling to and from the site for the clinic/practice/competition whether or not the event actually occurs.
